IMPORTANT: Paint colors must be a scheme from the pre-approved color scheme list. The applicant must provide selected scheme with the colors and codes. **The exterior paint scheme must include all painted areas of the house structure and the exterior side of the surrounding block wall. The exterior street facing block walls, front and side, must be painted the same color as the body of the home.** Any outbuildings, other structures, and any other hardscape visible from neighboring property, common areas, or the street, will also be considered to be part of the exterior paint scheme and are to be painted the same as the body of the house. Owner shall have the option to use two colors in lieu of three, but must use the body color within the pre-approved scheme chosen. The second color used must be either the trim or accent within the chosen scheme and must be used for all accent and trim areas. **Garage Door and Front Door must match either the Body or Pop Out color.**
